This court, in concurrence with the decision of the trial court, held that a cause of action for professional malpractice accrues at the time of the allegedly negligent act and not at the time of the resulting injury. In *Whittaker v. Robinson*, supra, the court of appeals recognized a public policy reason for this court's decision in *Farrar* that a cause of action for professional malpractice does not accrue until the client discovers or should have discovered his or her injury and then held that a cause of action for medical malpractice accrues at the time of the negligent act and not at the time of the resultant injury. In that case, the court of appeals found that the legislature had expressed a public policy judgment to the contrary, in that, in a medical malpractice action, the statute of limitations begins to run from the time of the alleged negligent act. *Id.* at 851.
